Licensing Requirements and Application Checklist Private and Electronic Security Firms

License Requirements for Security Firm

Below are the minimum requirements that must be met in order to be licensed in the state of Montana.

1. Firm must be registered with the Montana Secretary of State - [[37-60-303\(7a\) MCA](#)]
2. A completed security Firm application form with the appropriate fee to obtain a Firm license for the applicant's principal place of business. [[ARM 24.182.525](#)]
3. All applications must comply with the requirements stated in [[ARM 24.182.405](#), [ARM 24.182.407](#), and [ARM 24.182.501](#)]
4. The Firms Designated Manager shall certify that each employee has completed the training program as applicable - [[ARM 24.182.807](#), [ARM 24.182.810](#) and [ARM 24.182.813](#)]
5. Shall maintain the following level of insurance - [[ARM 24.182.405](#)]:
 - a. Electronic security Firms shall maintain a minimum of \$500,000 occurrence form of commercial general liability which includes personal injury and errors and omissions coverage.
 - b. Private security Firms shall maintain a minimum of \$500,000 occurrence form of commercial general liability which includes personal injury. Employee(s) licensed with armed status shall carry liability for firearms coverage.
6. Has a designated manager at the time of application - [[37-60-302 MCA](#)]
7. Employee uniforms must be approved by the Department. - [[ARM 24.182.407](#)]

Checklist of Required Documents to Submit for Application for Security Firm

The following documents and additional forms are required in addition to the basic application. Some documents may be submitted directly by the applicant as part of the application. Others may need to be sent to the Department directly from the source.

- Official license verification from states and jurisdictions in which the Firm holds or has ever held a professional license of any type.
- Proof of current insurance (certificate) as described above.
- Proof of registration of Firm with Montana Secretary of State.
- Photographs of employee uniforms for Board approval.
- Identify designated manager.



Application Fee(s) for Security Firm

The following fee(s) must be submitted with the application. Online applicants can pay using a credit card or e-check. If you submit a paper application, you must submit a check. Do not mail cash.

- \$250.00 application fee (each business entity)

You can apply for a license online at <https://ebiz.mt.gov/POL/> or download a paper application from the website. Online application is recommended.
