Licensing Requirements and Application Checklist Electrologist by Credentialing

License Requirements for Electrologist by Credentialing

Below are the minimum requirements you must meet in order to be licensed in the state of Montana.

- 1. Must be at least 18 years or older <u>37-31-304 MCA **24.121.603** LICENSURE BY CREDENTIALING WITH AN OUT-OF-STATE LICENSE</u>
- 2. Must be a high school graduate or equivalent <u>37-31-304</u> MCA <u>24.121.610</u> GRANTING EXCEPTION TO HIGH SCHOOL DIPLOMA OR EQUIVALENCY
- 3. Must have a current unencumbered license in another state in the profession they seek licensure 24.121.603 LICENSURE BY CREDENTIALING WITH AN OUT-OF-STATE LICENSE
- 4. All applicants are required to take the national written and practical portions of a Board approved exam unless their state of licensure currently accepts the National Interstate Council of Boards of Cosmetology (NIC) exam <u>37-31-304</u> MCA <u>24.121.603</u> <u>LICENSURE BY CREDENTIALING WITH AN</u> OUT-OF-STATE LICENSE
- Applicant must have education/training substantially equivalent to the scope of practice of the Montana license they are applying for. <u>24.121.603</u> <u>LICENSURE BY CREDENTIALING WITH AN OUT-OF-STATE LICENSE</u> <u>24.121.604</u> <u>LICENSURE EQUIVALENCY FOR PROFESSIONAL EDUCATION</u> and
 - Applicant may attest to the minimum hours of work experience in their profession in another state that meet the requirements of 24.121.603 LICENSURE BY CREDENTIALING WITH AN OUT-OF-STATE LICENSE(4) as follows:
 - a. Electrology: either have completed at least **600** hours of electrology training in a school or attest to at least **1,200** hours of work experience as a licensed electrologist.

Checklist of Required Documents to Submit for Application for Electrologist by Credentialing

The following documents and additional forms are required <u>in addition</u> to the basic application. Some documents may be submitted directly by the applicant as part of the application. Others, such as transcripts, may need to be sent to the board directly from the source.

Proof of age; current driver's license or other legal document confirming age 37-31-304 MCA
24.121.603 LICENSURE BY CREDENTIALING WITH AN OUT-OF-STATE LICENSE
Official license verification of current licensure in the profession from states and jurisdictions in which
the applicant holds or has ever held a professional license of any type 24.121.603 LICENSURE BY
CREDENTIALING WITH AN OUT-OF-STATE LICENSE
License verification may state the educational hours to compare for equivalency, or applicant furnishes
transcripts showing the required hours, or the applicant attests to experience as allowed in
24.121.603 LICENSURE BY CREDENTIALING WITH AN OUT-OF-STATE LICENSE
Proof of graduation from an approved school or course of Electrology with the required hours of training
