## Licensing Requirements and Application Checklist Nursing Home Administrator

1. <u>License Requirements for Nursing Home Administrator [MCA 37-9-301]</u>

Below are the minimum requirements you must meet in order to be licensed in the state of Montana.

- 2. Applicant must be of good moral character. [MCA 37-9-301]
- 3. Applicant must have received a high school diploma or equivalent. [MCA 37-9-301] [ARM 24.162.501]
- 4. Applicant must have completed an approved course of instruction and training in long term care facilities <u>or</u> presented evidence of a combination of education, training, and experience for long term care facilities. [MCA 37-9-301] [ARM 24.162.501]
- 5. Applicant must have passed an approved examination. [MCA 37-9-301]

## **Checklist of Required Documents to Submit for Application for Nursing Home Administrator**

The following documents and additional forms are required <u>in addition</u> to the basic application. Some documents may be submitted directly by the applicant as part of the application. Others, such as transcripts and examination verifications, must be sent to the board directly from the source.
