## Licensing Requirements and Application Checklist APRN

## **License Requirements for APRN**

Below are the minimum requirements you must meet in order to be licensed in the state of Montana.

- 1. An official transcript sent to the board directly from the education institution, verifying date of graduation and graduate-level degree conferred [ARM 24.159.1412, ARM 24.159.1418]
- 2. Must hold an active MT RN license or RN license with a multistate privilege from a compact state [ARM 24.159.1412, ARM 24.159.1418]
- 3. Submit current and valid APRN Certification -[ARM 24.159.1412, ARM 24.159.1418]
- 4. Submit verification of APRN licensure status from all jurisdictions for preceding two years [ARM 24.159.1412, ARM 24.159.1418]
- 5. Submit fingerprints for the purpose of a fingerprint and background check [MCA <u>37-8-434</u>]

## <u>Checklist of Required Documents to Submit for Application for APRN</u>

The following documents and additional forms are required <u>in addition</u> to the basic application. Some documents may be submitted directly by the applicant as part of the application. Others, such as transcripts, may need to be sent to the board directly from the source.
