## Licensing Requirements and Application Checklist Engineer Intern Certificate

## **License Requirements for Engineer Intern**

Below are the minimum requirements you must meet in order to receive an Engineer Intern certificate in the state of Montana. An Engineer Intern certificate does not authorize the holder to practice as a professional engineer.

- 1. Engineering education: This can be a Board-approved Bachelor's or Master's degree in engineering or engineering technology or a Bachelor's degree in a science curriculum that is not Board-approved. [MCA 37-67-324, ARM 24.183.303, ARM 24.183.501]
- 2. Passage of NCEES Fundamentals of Engineering (FE) exam. [MCA 37-67-324, MCA 37-67-327]
- 3. For applicants with a degree that is not Board-approved, 4 years of engineering experience under the supervision of a U.S.-licensed Professional Engineer. [MCA 37-67-324, ARM 24.183.303, ARM 24.183.702]

NOTE: Experience is not required for applicants with a Board-approved degree.

4. 3 character references. – [MCA 37-67-324, ARM 24.183.503]

NOTE: Applicants who apply with a degree that is not Board-approved and 4 years of experience are excluded from most pathways available for Montana licensure as a Professional Engineer. Please see MCA 37-67-324 and MCA 37-67-323 for details.

## **Checklist of Required Documents to Submit for Application for Engineer Intern**

The following documents and additional forms are required <u>in addition</u> to the basic application. All must be sent to the board directly from the source. Any of these documents received from the applicant will not be accepted.

	documentation from the source (licensing board, federal agencies/programs, or civil/criminal court proceedings such as initiating/charging documents, final disposition/judgement documents, etc.)  cation Fee(s) for Engineer Intern
The fo	llowing fee(s) must be submitted with your application. Online applicants can pay using a credit card or ck. If you submit a paper application you must submit a check. Do not mail cash.
	\$25 application fee NOTE: Any examination fees charged by NCEES for the Fundamentals of Engineering examination are not collected by the Board.
