- The Board finalized its 2015 legislative proposal as developed through its Model Law Committee.

## **OTHER BOARD NEWS:**

- The Board's "Notice of Adoption" of new rules, amended rules and repealed rules was published by the Secretary of State on November 20, 2014. Those rule changes now are effective. The new rules include new fees for many of the Board's license applications and renewals. In addition, Engineer Intern and Land Surveyor Intern certificates now are valid for two years and may be renewed. The Board also has a new section on Unprofessional Conduct."
