- 2) Answer the disciplinary question at the bottom of the form.
- 3) Review the Continuing Education statement below.
- 4) Submit a check or money order for the total of all the licenses you wish to renew. Make payable to the Board of Pharmacy. Do not send cash. Canadian and foreign residents pay in U.S. funds only.
- 5) Renewals with a U.S. Postal Service postmark after June 30 will be assessed a penalty per the above schedules.  
**NO EXCEPTIONS!**
- 6) Sign the completed renewal application.
- 7) Return the completed renewal application and fee to the Board office postmarked by June 30.
- 8) A renewal returned to a licensee for any reason must be re-postmarked by June 30 to avoid paying the late fee.

**MPDR FEE STATEMENT:**

All Montana licensees who are authorized to prescribe or dispense controlled substances in Schedules II-V are required to pay a \$30 annual fee for establishing and maintaining the Montana Prescription Drug Registry (MPDR); see Montana Code Ann. Sec. 37-7-1511 (1), effective July 1, 2015, as amended by the Montana Legislature. The MPDR is administered by the Board of Pharmacy. The MPDR Fee is collected as a separate fee as part of license renewal. Payment is required whether or not the licensee is physically located in Montana or uses the MPDR online program.

**CONTINUING EDUCATION UNIT (CEU) STATEMENT:**

The Board requires 1.5 CEU (15 clock hours) with a minimum of 5 hours to be obtained in an approved group setting **OR** 2.0 CEU (20 clock hours) if you do not take at least 5 hours in an approved group program. The CEU is required within 12 months prior to June 30 in order to renew your license. An additional 15 hours may be accumulated and applied to the following licensing year. Once approved, a course may not be used more than once to satisfy the requirement. Pharmacists renewing as a new graduate are exempt from this requirement. Pharmacists residing in another state are required to meet Montana’s requirement for continuing education.

The Board will be conducting a random audit of licensees following the renewal to insure compliance. If you are among those selected, you will be notified to submit documentation that you have completed the requirement.

ANY CEU NON-COMPLIANCE DETERMINED BY THE AUDIT WILL BE HANDLED BY THE BOARD AS A DISCIPLINARY MATTER.
