- 1) Complete the Journeyman employment questions.
- 2) Read the continuing education statement.
- 3) Answer the disciplinary question.
- 4) Sign the renewal application.
- 5) Submit a check or money order in the amount indicated above, made payable to the Montana Board of Plumbers. Do not send cash.
- 6) If the renewal is postmarked after September 1, the license will be in a lapsed status for 45 days. After the 45 days, the license will expire and the licensee is considered to be practicing without a license. The license can be reactivated for up to 2 years following the date of renewal, but all renewal and late fees are to be paid.
