- 3) In accordance with ARM 24.182.421(1) Licensees with armed status shall requalify annually with a Montana POST certified instructor or a Montana licensed certified firearms instructor (CFI) to maintain their firearm endorsement each year. Requalification will be based upon satisfactory completion of a board approved combat shooting course at least once during each year.
