According to **ARM 24.216.2102 (6)** the following education programs are approved by the board for continuing education credit:

Workshops, seminars and educational conferences sponsored by:

- National Environmental Health Association (NEHA)
- Montana Environmental Health Association (MEHA)
- Montana Department of Environmental Quality (DEQ)
- Montana Department of Health and Human Services (DPHHS)

Accreditation and refresher courses in specialized programs (like UST licensure, asbestos accreditation, FDA standardization, etc.) sponsored by:

- Environmental Protection Agency (EPA)
- State agencies
