Licensing Requirements and Application Checklist Audiologist (currently licensed out-of-state)

License Requirements for Audiologist (currently licensed out-of-state)

Below are the minimum requirements you must meet in order to be licensed in the state of Montana.

1. Hold a current, active license in good standing in another state or jurisdiction to practice audiology. That state or jurisdiction must have licensing requirements which are substantially equivalent to Montana - [[MCA 37-15-303](#), [ARM 24.222.506](#)(2)(a)]
2. Graduation from a program accredited by the Council on Academic Accreditation in Audiology and Speech-Language Pathology of the American Speech-Language-Hearing Association or the Accreditation Commission for Audiology Education (ACAE) - [[MCA 37-15-303](#), [ARM 24.222.506](#)(2)(b)]
3. Pass the national PRAXIS exam [[37-15-303](#), [MCA](#), and [ARM 24.222.506](#)(2)(c), [24.222.510](#)(1)(a)]
4. Pass the open-book state jurisprudence examination which is included with the application. A passing score is 80% or greater - [[MCA 37-15-303](#), [ARM 24.222.506](#)(2)(d), [24.222.510](#)(1)(b) and (2)]

Checklist of Required Documents to Submit for Application for Audiologist (currently licensed out-of-state)

The following documents and additional forms are required in addition to the basic application. Some documents may be submitted directly by the applicant as part of the application. Others, such as transcripts, may need to be sent to the board directly from the source.

Applicants WITH a current certificate of clinical competence from ASHA must submit the following documents.

- Official license verification from states and jurisdictions in which you hold or have ever held a professional license of any type. It is up to you to request official verification from those states and jurisdictions. Montana accepts whatever official form of verification is offered by other states or jurisdictions.
- Proof of the current certificate of clinical competence from ASHA
- Completed, open-book [state jurisprudence exam](#) which will be graded by department staff. If you do not pass you will be contacted by department staff so you can retake the exam.
- If you answered yes to discipline questions, include a detailed explanation on the event(s) and documentation from the source (licensing board, federal agencies/programs, or civil/criminal court proceedings such as initiating/charging documents, final disposition/judgement documents, etc.).

Applicants WITHOUT a current certificate of clinical competence from ASHA must submit the following documents.

- Official license verification from states and jurisdictions in which you hold or have ever held a professional license of any type. It is up to you to request official verification from those states and jurisdictions. Montana accepts whatever official form of verification is offered by other states or jurisdictions.

- The web address and direct link to the most current licensing regulations for the state or jurisdiction in which you are currently licensed. Staff will use the link to access the most current licensing laws to determine whether that state or jurisdiction has licensing standards which are substantially equivalent to Montana standards.
- Certified education transcripts sent directly to the department from the college or university. If you were licensed prior to January 1, 2007, a doctorate is not necessary.
- Results from the PRAXIS exam sent directly from the testing agency.
- Completed, open-book [state jurisprudence exam](#) which will be graded by department staff. If you do not pass you will be contacted by department staff so you can retake the exam.
- If you answered yes to discipline questions, include a detailed explanation on the event(s) and documentation from the source (licensing board, federal agencies/programs, or civil/criminal court proceedings such as initiating/charging documents, final disposition/judgement documents, etc.).

Application Fee(s) for Audiologist (currently licensed out-of-state)

The following fee(s) must be submitted with your application. Online applicants can pay using a credit card or a bank account. If you submit a paper application you must submit a check or money order. Do not mail cash.

- \$192 application fee

You can apply for a license online at <https://ebiz.mt.gov/POL/> or download a paper application from the website. Online application is recommended.
