- 1) Complete the renewal application.
- 2) Answer the disciplinary question at the bottom of the form.
- 3) Submit a check or money order for \$60.00 made payable to the Board of Radiologic Technologists. Do not send cash. Canadian and foreign residents pay in U.S. funds only.
- 4) Renewals postmarked after February 1 will be assessed a penalty fee of \$60.00, increasing the total amount due to \$120.00. NO EXCEPTIONS!
- 5) Sign the renewal application.
- 6) Return the renewal application and fee to the Board office by February 1.
- 7) Incomplete or unsigned renewal applications will not be processed and will be returned.

CONTINUING EDUCATION REQUIREMENT AND STATEMENT:
Limited Permit Holders are required to obtain 6 hours of continuing education annually. The Board will be conducting a random audit of licensees following the renewal cycle to ensure compliance. If you are among those selected you will be notified after March 18 to submit documentation that you have completed the requirement.
