In order to renew your license:

- 1) Complete the renewal application.
- 2) Answer the disciplinary question at the bottom of the form.
- 3) Submit a check or money order for \$75.00 made payable to the Board of Radiologic Technologists. Do not send cash. Canadian and foreign residents pay in U.S. funds only.
- 4) Renewals postmarked after February 1 will be assessed a penalty fee \$75.00, increasing the total amount due to \$150.00. **NO EXCEPTIONS!**
- 5) Sign the renewal application.
- 6) Return the renewal application and fee to the Board office by February 1.
- 7) Incomplete or unsigned renewal applications will not be processed and will be returned.

CONTINUING EDUCATION STATEMENT:

Radiologic Technologists are required to obtain 24 hours of continuing education through the American Registry of Radiologic Technologists (ARRT) and have a current ARRT card as evidence in order to renew their license.

I was grandfathered during early 1970's and do not need proof of an ARRT Card.

The Board will be conducting a random audit of licensees following the renewal cycle to ensure compliance. If you are among those selected, you will be notified after March 18 to submit documentation that you have completed the requirement.
