Licensing Requirements and Application Checklist Licensed Marriage and Family Therapist Candidate (MFLC)

- This checklist is for applicants who have <u>NOT</u> already completed 3000 hours of supervised work experience.
- If you have already completed 3000 hours of supervised work experience and/or are licensed as an LMFT in another jurisdiction you may qualify for licensure as an LMFT. See the <u>LMFT application</u> <u>checklist</u>.

License Requirements for LMFT Candidate

Below are the minimum requirements you must meet to be licensed in the state of Montana.

- 1. You must meet the education requirements as described in either Option 1, Option 2, <u>or</u> Option 3 [<u>ARM 24.219.701(2)</u>]
 - Option 1: minimum of a master's degree from a program accredited by the Commission on Accreditation for Marriage and Family Therapy Education (COAMFTE)
 - Option 2: minimum of a master's degree in marriage and family counseling from a program accredited by the Council for the Accreditation of Counseling and Related Educational Programs (CACREP) or the Commission on Accreditation for Marriage and Family Therapy Education (COAMFTE)
 - Option 3: minimum of a master's degree from an accredited institution consisting of a minimum of 60 semester hours or 90 quarter hours. Those hours must include a minimum of 48 semester hours or 72 quarter hours of courses in:
 - i. foundations of relational/systemic practice, theories, and models;
 - ii. biopsychosocial health and development across the life span;
 - iii. clinical treatment with individuals, couples, and families;
 - iv. ethics in marriage and family therapy;
 - v. diverse, multicultural, and/or underserved communities; and
 - vi. systemic/relational assessment and mental health diagnosis and treatment
- 2. Supervision by a supervisor who meets the requirements in <u>ARM 24.219.421</u>
- 3. Submit fingerprints to the Montana Department of Justice for a fingerprint background check. [<u>37-37-</u><u>205</u>]

Checklist of Required Documents to Submit for Application for LMFT Candidate

The following documents and additional forms are required <u>in addition</u> to the basic application. Some documents may be submitted directly by the applicant as part of the application. Others, such as transcripts, may need to be sent to the board directly from the source.

Official license verification from states and jurisdictions in which you hold or has ever held a professional license of any type. Montana accepts whatever official form of verification is offered by other states or jurisdictions.



- □ If you answered yes to discipline questions, include a detailed explanation on the event(s) and documentation from the source (licensing board, federal agencies/programs, or civil/criminal court proceedings such as initiating/charging documents, final disposition/judgement documents, etc.),
- Certified education transcript(s) sent directly to the department from the college or university.
- □ Completed fingerprint and background check results sent directly to the department from the Montana Department of Justice (<u>click here to access the forms you will need to submit to the Department of Justice</u>)
- □ <u>Noncriminal Justice Applicant's Rights</u> form
- □ <u>Training and Supervision Plan</u> form
- □ For applicants who have completed some but not all of Montana's required supervised experience hours in another jurisdiction or up to 500 hours that was completed pre-graduation as part of the degree
 - Applicants currently licensed in another jurisdiction may submit that jurisdiction's documentation showing completion of those hours; or complete the Montana <u>Evaluation of</u> <u>Supervised Experience</u> form if that jurisdiction's supervisor(s) is available to sign the form.
 - Applicants not currently licensed in another jurisdiction who previously obtained hours in another jurisdiction may submit that jurisdiction's documentation showing completion of those hours; or complete the Montana <u>Evaluation of Supervised Experience</u> form if that jurisdiction's supervisor(s) is available to sign the form.
 - Applicants who earned up to 500 hours as part of their degree may submit documentation from the school showing completion of those hours; or complete the Montana <u>Evaluation of</u> <u>Supervised Experience</u> form if that supervisor(s) is available to sign the form.

Application Fee(s) for LMFT Candidate

The following fee(s) must be submitted with your application. Online applicants can pay using a credit card or e-check. If you submit a paper application you must submit a check. Do not mail cash.

□ \$200 application fee

You can apply for a license online at <u>https://ebiz.mt.gov/POL/</u> or download a paper application from the website. Online application is recommended.
