Licensing Requirements and Application Checklist Licensed Clinical Professional Counselor Candidate (PCLC)

- This checklist is for applicants who have **NOT** already completed 3000 hours of supervised work experience.
- If you have already completed 3000 hours of supervised work experience and/or are licensed as an LCPC in another jurisdiction you may qualify for licensure as an LCPC. See the [LCPC application checklist](#).

License Requirements for LCPC Candidate

Below are the minimum requirements you must meet to be licensed in the state of Montana.

1. You must meet the degree requirements as described in either Option 1 or Option 2. [[MCA 37-23-202\(1\)\(b\)](#), [ARM 24.219.604](#)]
 - Option 1 - graduate degree with a minimum of 60 semester hours from an accredited college with a program of study that is primarily counseling in nature and includes 6 semester credits in an advanced counseling practicum. The program must include Council for Accreditation of Counseling and Related Educational Program (CACREP) core courses; or
 - Option 2 - graduate degree with a minimum of 45 semester hours from an accredited college with a program of study that is primarily counseling in nature and includes 6 semester credits in an advanced counseling practicum. The program must include Council for Accreditation of Counseling and Related Educational Program (CACREP) core courses. **Note that if your degree is at least 45 credits but less than 60 credits and meets this criteria you will still have to obtain the additional credits to equal 60 within five years of being granted your LCPC license. 2. Proof of completion of 3,000 hours of supervised counseling experience. [[MCA 37-23-202\(1\)\(b\)](#), [ARM 24.219.604](#)]
3. Supervision by a supervisor who meets the requirements in [ARM 24.219.421](#)
4. Submit fingerprints to the Montana Department of Justice for a fingerprint and background check. [[MCA 37-23-202\(3\)](#)]

Checklist of Required Documents to Submit for Application for LCPC Candidate

The following documents and additional forms are required in addition to the basic application. Some documents may be submitted directly by the applicant as part of the application. Others, such as transcripts, may need to be sent to the board directly from the source.

- Official license verification from states and jurisdictions in which you hold or has ever held a professional license of any type. Montana accepts whatever official form of verification is offered by other states or jurisdictions.

- If you answered yes to discipline questions, include a detailed explanation on the event(s) and documentation from the source (licensing board, federal agencies/programs, or civil/criminal court proceedings such as initiating/charging documents, final disposition/judgement documents, etc.),
- Certified education transcript(s) sent directly to the department from the college or university.
- Completed fingerprint and background check results sent directly to the department from the Montana Department of Justice ([click here to access the forms you will need to submit to the Department of Justice](#))
- [Noncriminal Justice Applicant's Rights](#) form
- [Training and Supervision Plan](#) form
- [Academic Summary](#) form
- Proof of passage of one of the NBCC exams directly to the department from the NBCC
- For applicants who have completed some but not all of Montana's required supervised experience hours in another jurisdiction or up to 1500 hours that was completed pre-graduation as part of the degree**
 - **Applicants currently licensed in another jurisdiction** may submit that jurisdiction's documentation showing completion of those hours; or complete the Montana [Evaluation of Supervised Experience](#) if that jurisdiction's supervisor(s) is available to sign the form.
 - **Applicants not currently licensed in another jurisdiction who previously obtained hours in another jurisdiction** may submit that jurisdiction's documentation showing completion of those hours; or complete the Montana [Evaluation of Supervised Experience](#) form if that jurisdiction's supervisor(s) is available to sign the form.
 - **Applicants who earned up to 1500 hours as part of their degree** may submit documentation from the school showing completion of those hours; or complete the Montana [Evaluation of Supervised Experience](#) form if that supervisor(s) is available to sign the form.

Application Fee(s) for LCPC Candidate

The following fee(s) must be submitted with your application. Online applicants can pay using a credit card or e-check. If you submit a paper application you must submit a check. Do not mail cash.

- \$200 application fee

You can apply for a license online at <https://ebiz.mt.gov/POL/> or download a paper application from the website. Online application is recommended.
