NOTE: Any application requiring review by the Board must be complete (all documents and required information received by the Board) no later than 15 working days prior to the Board's next meeting. Please visit www.cosmetology.mt.gov for information on board meeting dates and plan accordingly.

ALL CREDENTIALING APPLICANTS

- Must be at least 18 years or older
- Must be a high school graduate or equivalent
- All applicants are required to take the written and practical portions of the Board approved national exam.
- Upon completion of all required curriculum hours, applicants must submit a complete license application and fee in order to become eligible to receive an Admission letter for the board approved national exam from the Board office.

LICENSURE BY CREDENTIALING WITH AN OUT-OF-STATE LICENSE

Applicants for licensure by credentialing must submit a completed application electronically or by paper, including appropriate fees and required documentation.

To qualify for licensure by credentialing the applicant must submit the following documentation:

For a **BARBER** license:

- proof of age;
- proof of current unencumbered barber license in another state;
- license verification from each state or jurisdiction the applicant has been licensed in, whether the license is current or not; and
- proof of passage of both the written **and** practical **NIC** (National Interstate Council of State Boards of Cosmetology) barber exam at 75% proficiency or higher. If you have taken and passed the NIC exam in your state, you must submit proof of passage with your application. Otherwise, you will be required to take both the written and practical NIC examinations. Individual state board examinations are not acceptable. Please do not schedule your examinations without first obtaining prior approval from the Board.
- the applicant must possess a license type in good standing that includes scope of training and practice in *haircutting with proper uses of tools (e.g., shears, razor, clippers, and thinning shears); shampooing and scalp treatments; hairstyling, including weaves, braiding, and extensions; wet setting, blow drying, curling, and flat ironing; and the arranging of dry hair; hair coloring, hair lightening, waving, and relaxing; facial shaving with straight razor; and skin care; and*

- either have completed a course of training of at least 1,100 hours in a school or attest to 2,200 hours of work experience as a licensed barber.

For a **BARBER NONCHEMICAL** license:

- proof of age;
- proof of current unencumbered barber license in another state;
- license verification from each state or jurisdiction the applicant has been licensed in, whether the license is current or not; and
- proof of passage of both the written **and** practical **NIC** (National Interstate Council of State Boards of Cosmetology) barber exam at 75% proficiency or higher. If you have taken and passed the NIC exam in your state, you must submit proof of passage with your application. Otherwise, you will be required to take both the written and practical NIC examinations. Individual state board examinations are not acceptable. Please do not schedule your examinations without first obtaining prior approval from the Board.
- either have completed a course of training of at least 900 hours in a school or attest to 1,800 hours of work experience as a licensed barber.

For a **COSMETOLOGY** license:

- proof of age;
- proof of current unencumbered cosmetology license in another state;
- license verification from each state or jurisdiction the applicant has been licensed in, whether the license is current or not; and
- proof of passage of both the written **and** practical **NIC** (National Interstate Council of State Boards of Cosmetology) cosmetology exam at 75% proficiency or higher. If you have taken and passed the NIC exam in your state, you must submit proof of passage with your application. Otherwise, you will be required to take both the written and practical NIC examinations. Individual state board examinations are not acceptable. Please do not schedule your examinations without first obtaining prior approval from the Board.
- the applicant must possess either:
 - (a) a license type in good standing that includes scope of training and practice in *manicuring and pedicuring, including massage and polishing, nail art, and use of an electric nail file; application and removal of artificial nails, gels, tips, and wraps; skin care, skin exfoliation, facials, makeup application, epilation, electricity and light therapies, and application of artificial lashes; hair coloring, hair lightening, waving, and relaxing; shampoo and scalp treatments; hairstyling, including weaves, braiding, and extensions; wet setting, blow drying, curling and flat ironing, and the arranging of dry hair; and haircutting with proper uses of tools (e.g., shears, razor, clippers, and thinning shears); and*
 - (b) either have completed a course of training of at least 1,500 hours in a school or attest to 3,000 hours of work experience as a licensed cosmetologist; **or**
 - (a) a combination of licensure in good standing that includes scopes of training and practice equal to:
 - (i) *hair coloring, hair lightening, waving, and relaxing; shampoo and scalp treatments; hairstyling, including weaves, braiding, and extensions; wet setting, blow drying, curling and flat ironing, and the arranging of dry hair* and have completed a course of training equal to or exceeding 900 hours in a school;
 - (ii) *manicuring; pedicuring; and applying and removing artificial nails, gels, tips, and wraps and use of an electric nail file* and have completed a course of training equal to or exceeding 200 hours in a school; and
 - (iii) *skin care; skin exfoliation, facials, and makeup application; epilation; electricity and light therapies; and application of artificial lashes* and have completed a course of training equal to or exceeding 400 hours in a school.

For an **ELECTROLOGY** license:

- proof of age;
- proof of current unencumbered electrology license in another state;
- license verification from each state or jurisdiction the applicant has been licensed in, whether the license is current or not; and
- proof of passage of both the written **and** practical **NIC** (National Interstate Council of State Boards of Cosmetology) electrology exam at 75% proficiency or higher. If you have taken and passed the NIC exam in your state, you must submit proof of passage with your application. Otherwise, you will be required to take both the written and practical NIC examinations. Individual state board examinations are not acceptable. Please do not schedule your examinations without first obtaining prior approval from the Board.
- the applicant must possess a license type in good standing that includes the scope of training and practice in *electrolysis; thermolysis; the blend; electricity, chemistry, and light therapy; and epilation* and either

have completed at least 600 hours of electrology training in a school or attest to at least 1,200 hours of work experience as a licensed electrologist.

For a **MANICURIST** license:

- proof of age;
- proof of current unencumbered manicurist license in another state;
- license verification from each state or jurisdiction the applicant has been licensed in, whether the license is current or not; and
- proof of passage of both the written **and** practical **NIC** (National Interstate Council of State Boards of Cosmetology) manicurist exam at 75% proficiency or higher. If you have taken and passed the NIC exam in your state, you must submit proof of passage with your application. Otherwise, you will be required to take both the written and practical NIC examinations. Individual state board examinations are not acceptable. Please do not schedule your examinations without first obtaining prior approval from the Board.
- the applicant must possess a license type in good standing that includes the scope of training and practice in *manicuring; pedicuring; and applying and removing artificial nails, gels, tips, and wraps and use of an electric nail file* and either have completed at least 400 hours of manicuring training in a school or attest to at least 800 hours of work experience as a licensed manicurist.

For an **ESTHETICIAN** license:

- proof of age;
- proof of current unencumbered esthetician license in another state;
- license verification from each state or jurisdiction the applicant has been licensed in, whether the license is current or not; and
- proof of passage of both the written **and** practical **NIC** (National Interstate Council of State Boards of Cosmetology) esthetician exam at 75% proficiency or higher. If you have taken and passed the NIC exam in your state, you must submit proof of passage with your application. Otherwise, you will be required to take both the written and practical NIC examinations. Individual state board examinations are not acceptable. Please do not schedule your examinations without first obtaining prior approval from the Board.
- the applicant must possess a license type in good standing that includes the scope of training and practice in *skin care; skin exfoliation, facials, and makeup application; epilation; electricity and light therapies; and application of artificial lashes* and either have completed at least 650 hours of esthetician training in a school or attest to at least 1,300 hours of work experience as a licensed esthetician.

APPLICATION PROCEDURES

When the application file is complete, it will be processed by Board staff for permanent licensure.

An incomplete or non-routine application may be a delayed. You may be requested to provide additional information or to make a personal appearance before the Board during a regularly scheduled Board meeting. These applications may take up to 120 days to process.

All verifications of licensure must be sent directly from each state board in which the applicant is currently or has ever been licensed. Some states may charge a fee for verification. Contact each state board for its requirements.

Keep the Board office informed at all times of any address change, change in license status and complaints or proposed disciplinary action. This is essential for timely processing of applications and subsequent licensure.

PROCESSING PROCEDURES

Once a complete routine application is received, processing may require up to 10 days to process.

The applicant will be notified in writing of any deficient or missing items from the application file.

All applicants will be issued appropriate eligibility and/or Admission letters to take both portions of the required National Exam.

Once a routine application is processed and approved, a permanent license will be issued.
