**OR:**

- 1) Complete all the information on the renewal application, including the CE question.
- 2) Answer the disciplinary question at the bottom of the form.
- 3) Submit a check or money order for \$40.00, payable to the Board of Architects. DO NOT SEND CASH. Canadian and foreign residents pay in U.S. funds only.
- 4) Renewals with a U.S. Postal Service postmark after June 30 will be assessed a penalty fee by state law of 100% of the unabated renewal fee, increasing the total amount due to \$80.00.
- 5) Sign the renewal application and return it to the Board office with the appropriate fee on or before June 30.
- 6) Incomplete or unsigned renewal applications will be returned and may be subject to the penalty fee if not recieved in the Board office completed and postmarked by June 30.
- 7) Indicate any address correction or change where requested at the top of the form.

I declare under penalty of perjury that all statements are true. I am aware that a false statement may lead to license discipline.

**RETIRED STATUS:** If you have retired and certify that you are no longer receiving any remuneration from providing architectural services you may omit completing this renewal form and contact the board office to receive information on applying for Emeritus Status or obtain an Emeritus Application on our website at [www.architect.mt.gov](http://www.architect.mt.gov).
