# Licensing Requirements and Application Checklist Licensed Master's (non-clinical) Social Worker (LMSW)

- This checklist is for applicants who <u>HAVE</u> already completed 2000 hours of supervised work experience.
- If you have NOT already completed 2000 hours of supervised work experience and/or are NOT licensed as an LMSW in another jurisdiction you may qualify for licensure as an LMSW candidate.
   See the LMSW candidate application checklist.

#### License Requirements for LMSW Not Currently Licensed in Another Jurisdiction

Below are the minimum requirements you must meet to be licensed in the state of Montana.

- 1. Minimum of a master's degree in social work from a program accredited by the Council on Social Work Education (CSWE) or a program currently in CSWE candidacy status.
- 2. Proof of completion of 2,000 hours post-graduate supervised work experience over a minimum of 18 months per the requirements in MCA 37-22-308 and ARM 24.219.504.
- 3. Submit fingerprints to the Montana Department of Justice for a fingerprint and background check. [MCA 37-22-308].
- 4. Proof of passage of the Association of Social Work Boards' (ASWB) master's licensing exam within four years of the date of application [ARM 24.219.502(2)].

### License Requirements for LMSW Currently Licensed in Another Jurisdiction

- 1. Meet all the criteria above for applicants not currently licensed; **OR**
- 2. Hold a current, active license in good standing in another state or jurisdiction that has current licensing requirements that are substantially equivalent to Montana standards; **AND**
- a. has completed supervised post-degree work that meets the requirements in ARM 24.219.504;
- b. has passed an exam as described above [ARM 24.219.502]; AND
- 3. Submit fingerprints to the Montana Department of Justice for a fingerprint and background check. [MCA 37-22-308].

\*If the licensing requirements in the state you hold a license are not substantially equivalent you can count experience as an LMSW for education if: a. your degree is at least 48 semester or 72 quarter credits; **and** you completed five years of post-degree experience in non-clinical social work in addition to the supervised work experience.

#### Checklist of Required Documents to Submit for Application for LMSW

The following documents and additional forms are required <u>in addition</u> to the basic application. Some documents may be submitted directly by the applicant as part of the application. Others, such as transcripts, may need to be sent to the board directly from the source.



Official license verification from states and jurisdictions in which you hold or has ever held a professional license of any type. Montana accepts whatever official form of verification is offered by other states or jurisdictions.

documentation from the source (licensing board, federal agencies/programs, or civil/criminal court

Completed fingerprint and background check results sent directly to the department from the Montana
Department of Justice (click here to access the forms you will need to submit to the Department of
Justice)
Noncriminal Justice Applicant's Rights form
Proof of passage of the ASWB exam directly to the department from the ASWB
Proof of completion of 2000 hours of supervised experience which meets the requirements in ARM

- Applicants currently licensed in another jurisdiction may submit that jurisdiction's
  documentation showing completion of those hours; or complete the Montana <u>Evaluation of</u>
  <u>Supervisory Experience</u> form if that jurisdiction's supervisor(s) is available to sign the form.
- Applicants not currently licensed in another jurisdiction who previously obtained hours in another jurisdiction may submit that jurisdiction's documentation showing completion of those hours; or complete the Montana <u>Evaluation of Supervisory Experience</u> form if that jurisdiction's supervisor(s) is available to sign the form.

## **Application Fee(s) for LMSW**

The following fee(s) must be submitted with your application. Online applicants can pay using a credit card or e-check. If you submit a paper application, you must submit a check. **Do not mail cash**.
