Licensing Requirements and Application Checklist Construction Blaster

Before applying, please be aware of MCA 37-72-101(3):

This license does not apply to the private or commercial use of explosives by persons engaged in farming, ranching, logging, geophysical work, drilling or development of water, oil, or gas wells, or mining of any kind or to the private use of explosives in the removal of stumps and rocks from land owned by the person using the explosives.

License Requirements for Construction Blaster

Below are the minimum requirements you must meet in order to be licensed in the state of Montana.

- 1. Must be at least 18 years of age. [MCA 37-72-301]
- 2. A minimum of 2 years of construction blasting experience. [MCA 37-72-301, MCA 37-72-302, ARM 24.131.501]
- 3. Complete a 24-hour construction blasting training program. [MCA 37-72-301, MCA 37-72-302, ARM 24.131.405, ARM 24.131.501]

Construction Blasting [MCA 37-72-101(1)(b)]:

Means the use of explosives to:

- (i) reduce, destroy, or weaken any residential, commercial, or other building; or
- (ii) excavate any ditch, trench, cut, or hole or reduce, destroy, weaken, or cause a change in grade of any land formation in the construction of any building, highway, road, pipeline, sewer line, or electric or other utility line

Training Programs [ARM 24.131.405]:

Training programs in construction blasting must be recognized by the explosives and construction industry and approved by the bureau. The training program must offer comprehensive instruction in safe use of explosives, methods and purposes of their use, and safety procedures for storage. These training programs shall be at least 24 hours to obtain a license or be approved by the bureau based on content and quality of the course.

All license applications expire within 1 year of initial submission to the department.

proceedings such as initiating/charging documents, final disposition/judgement documents, etc.).
