Licensing Requirements and Application Checklist for Barber by Exam

License Requirements for Barber by Exam

Below are the minimum requirements you must meet in order to be licensed in the state of Montana.

- 1. Must be at least 18 years or older 37-31-304 MCA 24.121.601 LICENSURE BY EXAMINATION
- Must be a high school graduate or equivalent <u>37-31-304</u> MCA <u>24.121.601</u> <u>LICENSURE BY EXAMINATION</u> <u>24.121.610</u> <u>GRANTING EXCEPTION TO HIGH SCHOOL DIPLOMA OR EQUIVALENCY</u>
- 3. All Applicants are required to take the national written and national practical portions of the Board approved exam. 37-31-304 MCA 24.121.601 LICENSURE BY EXAMINATION
- 4. Students are eligible to take the board approved exam upon completion of 90 percent of their curriculum and prior to graduating per board rule 24.121.805 SCHOOL OPERATING STANDARDS. Schools will verify student school hours to insure eligibility for taking the national exam and will issue the eligibility to test letter for the exam. A person may submit a license application when the person is no more than 90 days from completing the requisite course of study given the person's current and expected rate of progression, however a license will not be issued until all requirements for licensure are met. 24.121.805 SCHOOL OPERATING STANDARDS

Checklist of Required Documents to Submit for Application for Barber by Exam

The following documents and additional forms are required <u>in addition</u> to the basic application. Some documents may be submitted directly by the applicant as part of the application. Others, such as transcripts, may need to be sent to the board directly from the source.

documentation from the source (licensing board, federal agencies/programs, or civil/criminal court
proceedings such as initiating/charging documents, final disposition/judgement documents, etc.).

Application Fee(s) for Barber by Exam

The following fee(s) must be submitted with your application. Online applicants can pay using a credit card or e-check. If you submit a paper application you must submit a check. Do not mail cash.
