Licensing Requirements and Application Checklist Cosmetologist by Exam

License Requirements for Cosmetologist by Exam

Below are the minimum requirements you must meet in order to be licensed in the state of Montana.

- 1. Must be at least 18 years or older 37-31-304 MCA 24.121.601 LICENSURE BY EXAMINATION
- Must be a high school graduate or equivalent <u>37-31-304 MCA <u>24.121.601 LICENSURE BY EXAMINATION</u> <u>24.121.610 GRANTING EXCEPTION TO HIGH SCHOOL DIPLOMA OR EQUIVALENCY</u>

- Completion of approved school or course of Cosmetology with the required hours of training <u>37-31-304</u> MCA <u>24.121.601</u> LICENSURE BY EXAMINATION
- 4. All Applicants are required to take the national written and national practical portions of the Board approved exam. <u>37-31-304 MCA **24.121.601** LICENSURE BY EXAMINATION</u>
- 5. Students are eligible to take the board approved exam upon completion of 90 percent of their curriculum and prior to graduating per board rule 24.121.805 SCHOOL OPERATING

Checklist of Required Documents to Submit for Application for Cosmetologist by Exam

The following documents and additional forms are required <u>in addition</u> to the basic application. Some documents may be submitted directly by the applicant as part of the application. Others, such as transcripts, may need to be sent to the board directly from the source.

proof of age; current driver's license or other legal document confirming age 37-31-304 MCA

proof of graduation from an approved school or course of Cosmetology with the required hours of

proof of high school diploma or its equivalent; 37-31-304 MCA 24.121.601 LICENSURE BY

proof of passage of both the written and practical NIC (National Interstate Council of State Boards of
