# Licensing Requirements and Application Checklist Electrologist by Exam

### <u>License Requirements for Electrologist by Exam</u>

Below are the minimum requirements you must meet in order to be licensed in the state of Montana.

- 1. Must be at least 18 years or older 37-31-304 MCA 24.121.601 LICENSURE BY EXAMINATION
- Must be a high school graduate or equivalent <u>37-31-304 MCA <u>24.121.601 LICENSURE BY EXAMINATION</u> <u>24.121.610 GRANTING EXCEPTION TO HIGH SCHOOL DIPLOMA OR EQUIVALENCY</u>
  </u>
- 3. Completion of approved school or course of Electrology with the required hours of training 37-31-304 MCA 24.121.601 LICENSURE BY EXAMINATION
- 4. All Applicants are required to take the national written and national practical portions of the Board approved exam. <u>37-31-304 MCA **24.121.601** LICENSURE BY EXAMINATION</u>
- 5. Students are eligible to take the board approved exam upon completion of 90 percent of their curriculum and prior to graduating per board rule <a href="https://example.com/24.121.805">24.121.805</a> SCHOOL OPERATING STANDARDS Schools will verify student school hours to insure eligibility for taking the national exam and will issue the eligibility to test letter for the exam. A person may submit a license application when the person is no more than 90 days from completing the requisite course of study given the person's current and expected rate of progression, however a license will not be issued until all requirements for licensure are met. <a href="https://example.com/24.121.805">24.121.805</a> SCHOOL OPERATING STANDARDS

#### Checklist of Required Documents to Submit for Application for Electrologist by Exam

The following documents and additional forms are required <u>in addition</u> to the basic application. Some documents may be submitted directly by the applicant as part of the application. Others, such as transcripts, may need to be sent to the board directly from the source.

proof of age; current driver's license or other legal document confirming age 37-31-304 MCA 24.121.601 LICENSURE BY EXAMINATION
proof of graduation from an approved school or course of Barbering, Barbering (non-chemical),
Cosmetology, Electrology, Esthetics, with the required hours of training or, if a Montana-licensed
cosmetologist, completion of a supplemental barbering course for a barber license; 37-31-304 MCA

EXAMINATION 24.121.610 GRANTING EXCEPTION TO HIGH SCHOOL DIPLOMA OR
EQUIVALENCY
If you answered yes to discipline questions, include a detailed explanation on the event(s) and
documentation from the source (licensing board, federal agencies/programs, or civil/criminal court
proceedings such as initiating/charging documents, final disposition/judgement documents, etc.).

#### Application Fee(s) for Electrologist by Exam

The following fee(s) must be submitted with your application. Online applicants can pay using a credit card or e-check. If you submit a paper application you must submit a check. Do not mail cash.
