Licensing Requirements and Application Checklist Denturist by Exam/Experience

License Requirements for Denturist by Exam/Experience

Below are the minimum requirements you must meet in order to be licensed in the state of Montana.

- 1. Applicant shall have completed formal training of not less than 2 years at an educational institution accredited by a national or regional accrediting agency recognized by the Montana Board of Regents. 37-29-303, MCA 24.138.511 DENTURIST APPLICATION REQUIREMENTS
- 2. Applicant shall have passed the Montana board approved written denturitry examination <u>37-29-303</u>, MCA <u>24.138.511</u> DENTURIST APPLICATION REQUIREMENTS
- 3. Applicant shall have passed the Montana board approved clinical denturitry examination. <u>37-29-303</u>, MCA **24.138.511** DENTURIST APPLICATION REQUIREMENTS
- 4. Applicant shall have completed a one-year internship under the supervision of a Montana licensed denturist **or** has three (3) years of experience as a denturist under licensure in another state or Canada to be eligible to waive the Internship. 37-29-303, MCA
- 5. Applicant shall pass a Montana Jurisprudence examination. **24.138.511 DENTURIST** APPLICATION REQUIREMENTS

<u>Checklist of Required Documents to Submit for Application for Denturist by Exam/Experience</u> 24.138.511 DENTURIST APPLICATION REQUIREMENTS or as referenced

The following documents and additional forms are required <u>in addition</u> to the basic application. Some documents may be submitted directly by the applicant as part of the application. Others, such as transcripts, may need to be sent to the board directly from the source.

Official license verification from states and jurisdictions in which the applicant holds or has ever held a professional license of any type if applicable
National Practitioner Data Bank (NPDB) self-query. The results will come to the applicant; upon receipt
they forward them to the Board office unopened .
Copy of Denturitry Diploma.
Official transcripts sent directly from an approved denturitry school.
Three reference letters of moral character (relatives may not be used as references). (This form can be
found with the application material.)
Copy of current CPR, ACLS or PALS card. <u>37-29-306</u> , MCA
Check or money order for the appropriate fees.
If you answered yes to discipline questions, include a detailed explanation on the event(s) and
documentation from the source (licensing board, federal agencies/programs, or civil/criminal court
proceedings such as initiating/charging documents, final disposition/judgement documents, etc.).
