## Licensing Requirements and Application Checklist Hearing Aid Dispenser (Upon Completing Requirements for a Trainee)

## License Requirements for Hearing Aid Dispenser [MCA 37-16-402]

Below are the minimum requirements you must meet in order to be licensed in the state of Montana.

- 1. Applicant must be of good moral character. [MCA 37-16-402]
- 2. Applicant must have education equivalent to a 4-year course in an accredited high school or holds a current license as an audiologist. [MCA 37-16-402]
- 3. Applicant must be free of contagious or infectious disease. [MCA 37-16-402]

documents may be submitted directly by the applicant as part of the application. Others, such as examination verifications, must be sent to the Department directly from the source.
