The purpose of the Medication Endorsement for Advanced Emergency Medical Technicians (AEMTs) is to provide the AEMT with the knowledge and skills to carry and administer medications that are not currently in the AEMT curriculum but are allowed with additional training and education.

The Medical Director should be aware of their staff's educational and training history and whether there is a need for additional training to meet the current [National Emergency Medical Services \(EMS\) Education Standards](#) to comply with the Montana ECP Scope of Practice and to meet the training requirements, as listed in the most recent version of the endorsements (2025). The medical director is responsible for the quality of all endorsement training through direct participation and/or oversight.

<p>List and describe medications which the AEMT may administer according to the Montana ECP Scope of Practice.</p> <p>Discuss special considerations for pregnant, pediatric, and geriatric patients.</p> <p>List and describe general properties of the approved medications.</p> <p>List and describe liquid, solid, and gas formulations of the approved medications.</p> <p>List and differentiate routes of approved medication administration to include intramuscular, subcutaneous, intranasal, intraosseous, intravenous, oral, and inhalation.</p> <p>Describe mechanisms of approved medications.</p> <p>Discuss considerations for storing the approved medications.</p> <p>Review the specific anatomy and physiology pertinent to the approved medication administration.</p> <p>Calculate drug dosages for the approved medications for adults, infants, and children.</p> <p>Discuss legal aspects affecting medication administration.</p> <p>Discuss the "six rights" of drug administration and correlate these with the principles of medication administration.</p> <p>Discuss medical asepsis and the differences between clean and sterile techniques.</p> <p>Describe the use of antiseptics and disinfectants.</p> <p>Describe the use of universal precautions and body substance isolation (BSI) procedures when administering medications.</p> <p>Describe the indications, equipment needed, techniques utilized, precautions, and general principles for each of the approved medications.</p>
ENDORSEMENT SKILLS DEMONSTRATED DURING COURSE
<p>Use universal precautions and body substance isolation (BSI) procedures during medication administration.</p> <p>Use clean technique during medication administration of all routes.</p> <p>Preparation and administration of all approved medications.</p> <p>Disposal of contaminated items and sharps.</p>

At the completion of training, the AEMT with medication endorsement may carry and administer the medications outlined in the Montana ECP Scope of Practice, as below.

1. Diphenhydramine intramuscular (IM) route
2. Hydrocortisone, methylprednisolone, dexamethasone intravenous (IV) and intraosseous (IO) routes
