### Executive Officer Report

#### **Greetings everyone!**

Welcome to the first ever newsletter for the Montana Board of Plumbers! As the current Executive Officer for the Electrical, Plumbers and Radiologic Technologists Boards, I hope you find this newsletter insightful, and direct. At this time, I am pleased to report that we should start to see a regular newsletter coming from the Montana Board of Plumbers. Below are several significant highlights about the Board and Department that has taken place over the last few years.

#### **Current licensee numbers:**

- 569 Journeyman Plumbers
- 678 Master Plumbers
- 77 Med Gas Endorsement

#### Legislation:

- 2011: Tried for Unlicensed Practice Bill and advertising without a license. The Bill did not pass.
- 2013: Tried for Unlicensed Practice Bill and Waiver of first citation fine if caught without license. Was added to the Department Bill which did not pass legislation.
- 2015: Tried for Unlicensed Practice Bill: Passed! Also passing was exemption
  of Apprentices under the Boards directive, Cite and Fine for first offense
  waived if the licensee can produce proof of a license in 5 days, establishing
  the ability for the board to have a practical exam if they choose.

#### Re-Organization and New Database:

Approximately 3 years ago, the Department was re-organized into Board Management and Licensing Bureaus. We believed that combining all the experts into these 2 groups would provide for better streamlining for boards and licensing experts, but also give us the ability to cross train more effectively. We also brought in the new eBiz system to help with online renewals and to get into the 21st century since our previous database was over 10 years old. Both have brought challenges and great success with many big advances still to come!

- Renewals will be due on September 1, 2016. Post cards will be mailed out sometime in August. Make sure to have your CE completed before this date.

# COMPLIANCE REPORT

Inspectors and Investigators have completed eleven plumbing related investigations as well as 368 license checks in the last twelve months (April 2015 – March 2016). The breakdown of those checks for various licensure levels is as follows:

Journeyman - 229

Master - 128

Med Gas - 9

Apprentice licenses are still required to be carried and checked by inspectors, although those numbers no longer reflect in our statistics. The Montana Registered Apprenticeship Program has taken over issuing identification cards for all apprentices in the program.

One citation was issued to an individual who was not licensed in Montana or could not produce a valid license at the time of the license check. In the age of cell phones inspectors are accepting a picture of licenses saved on a cell phone in place of the actual license. The photograph on the cell phone must include the entire license and be legible.

We have just completed an enhancement to the licensing check database that will provide information to the Board about the location that the license checks are taking place. This will allow for a better comparison of where the work is occurring in the state and where the inspections are taking place and the ability to adjust the inspectors focus accordingly. Stay tuned for updates on this enhancement as the new data starts to come in over the next few months!

## Bureau of Building & Measurement Standards

The Plumbing/Mechanical/Medical Gas Safety Section has several reminders for those working in the field:

As professionals it is important to remember what it takes to be efficient and purposeful in serving the people in our state. Generally, we are seeing quality workmanship of plumbing, mechanical and medical gas installations and realize education is the key. Proper education raises the quality of your installations and the confidence of your consumers. Consumer safety and well-being in homes, businesses and services is the number one goal, at the same time having a profitable balanced business works together to strengthen Montana economic base. The following information is for your consideration to help improve quality of life for us all.

It is asked that inspection requests be made as much in advance of the 24-hour minimum notice time as possible. Request an inspection on-line, text, email or by phone. It will protect you and your customer. Emails directly to the inspector seems to be the most helpful and efficient to inspectors. Mechanical Contractors are required to make application and obtain permits prior to beginning any commercial work and to call for inspections. 2012 International Mechanical Code Chapter 1, 106.1.

There have been instances of non-licensed persons setting plumbing finish fixtures for customers on jobs (posing as a cost savings to the customer) that have a plumbing permit. Plumbing contractors have been reluctant to notify the Department of Labor and Industry. However, it's important to consider if this situation is happening to you, you need to report it. Protecting the customer's investment and the liability of unsafe or improper plumbing installations are the responsibility of plumbing contractors.

Codes adopted by certified cities, counties or towns must be the same edition with the same amendments as those adopted by the Department of Labor and Industry, Building Codes Bureau. Consistency of inspections is a vital part of economics and efficiency.

County, city, or town appeal procedure. (1) If a county, city, or town adopts a building code, it shall also establish an appeal procedure by ordinance or resolution, as appropriate that is acceptable to the department. (2) If a county, city, or town does not adopt a code, appeals on the application of the state building code within the county, city, or town must be made to the Department of Labor and Industry Building Codes Bureau.

Persons that are certified to install medical gas must also apply for a Medical Gas endorsement from the Board of Plumbers and to have the endorsement with them when installing Medical Gas Systems.

Ready to retire from plumbing, but not ready to give up your license? You may apply for Retirement Status. Call the Board of Plumbers at 406-444-5711.
