## Licensing Requirements and Application Checklist Private Security Guard

### **License Requirements for Private Security Guard**

Below are the minimum requirements you must meet in order to be licensed in the state of Montana.

1. Applicant must be at least 18 years of age and has completed high school or equivalent education [[MCA 37-60-303](#)]
2. Each Private Security Guard applicant shall complete the required 16 hour training program [[MCA 37-60-303](#), [ARM 24.182.514](#), [ARM 24.182.807](#)]
3. Applicant is required to provide a background investigation that includes a fingerprint check by the Montana Department of Justice and the Federal Bureau of Investigation [[MCA 37-60-303](#) and [ARM 24.182.501](#)]
4. Applicant shall provide verification of employment by a Private Security Firm or other employer as a final condition for the Department to issue the license. [[ARM 24.182.514](#) and [ARM 24.182.301](#)]
5. Private Security Guards not employed by a Private Security Firm shall maintain a minimum of \$500,000 occurrence form of commercial general liability which includes personal injury. If endorsed for firearms, firearms liability insurance coverage is required [[MCA 37-60-202](#) and [ARM 24.182.405](#)]

### **Checklist of Required Documents to Submit for Application for Private Security Guard**

The following documents and additional forms are required in addition to the basic application. Some documents may be submitted directly by the applicant as part of the application. Others, such as transcripts, may need to be sent to the Department directly from the source.

- Official license verification from states and jurisdictions in which the applicant holds or has ever held a professional license of any type.
- If you answered yes to any personal history question, include a detailed explanation on the event(s) and documentation from the source (licensing board, federal agencies/programs, or civil/criminal court proceedings such as initiating/charging documents, final disposition/judgement documents, etc.).
- Applicant Rights and Consent to Fingerprint Notice (Privacy Act Statement).
- Send fingerprints to the Montana Department of Justice for a State and Federal criminal background check.
- Proof the applicant is employed or contracted to be employed by a Private Security Firm or other employer.
- Proof applicant has completed the 16-hour training program.
- Proof of insurance – Required if not employed by a Private Security Firm.

### **Application Fee(s) for Private Security Guard**

The following fee(s) must be submitted with your application. You can apply and pay online using a debit/credit card or bank account.

- \$80 application fee
