## Licensing Requirements and Application Checklist Licensed Residential Appraiser by Examination

### License Requirements for Licensed Residential Appraiser by Examination

Below are the minimum requirements you must meet in order to be licensed in the state of Montana.

1. Be of good moral character – [MCA [37-54-202](#)(1)(a)]
2. Basic appraisal principles 30 hours - [Appraiser Qualifications Board Criteria](#)
3. Basic appraisal procedures 30 hours
4. 15-hour national USPAP course
5. Residential market analysis and highest and best use 15 hours
6. Residential appraiser site valuation and cost approach 15 hours
7. Residential sales comparison and income approaches 30 hours
8. Residential report writing and case studies 15 hours
9. Must have 1,000 hours of appraisal experience obtained over a period of NOT less than 6 months
10. Pass the AQB-approved Licensed Residential Real Property Appraiser Examination – [ARM [24.207.501](#)]
11. Submit fingerprints for the purpose of a fingerprint and background check – [MCA [37-54-202](#)(3)]

### Checklist of Required Documents to Submit for Application for Licensed Residential Appraiser by Examination

The following documents and additional forms are required in addition to the basic application. Some documents may be submitted directly by the applicant as part of the application. Others, such as transcripts, may need to be sent to the board directly from the source.

- Official license verification from states and jurisdictions in which the applicant holds or has ever held a professional license of any type
- Fingerprint Background Check
- Noncriminal Justice Applicants Rights form
- Experience log showing necessary hours
- Education log and course certificates
- If you answered yes to discipline questions, include a detailed explanation on the event(s) and documentation from the source (licensing board, federal agencies/programs, or civil/criminal court proceedings such as initiating/charging documents, final disposition/judgement documents, etc.).

### Application Fee(s) for Licensed Residential Appraiser by Examination



The following fee(s) must be submitted with your application. Online applicants can pay using a credit card or e-check. If you submit a paper application you must submit a check. Do not mail cash.
