Licensing Requirements and Application Checklist Certified Euthanasia Agency

License Requirements for Certified Euthanasia Agency

Below are the minimum requirements you must meet in order to be licensed in the state of Montana.

- 1. Drug Enforcement Agency (DEA) permit to possess and store controlled substances for euthanasia [ARM 24.225.920(2)(b)]
- 2. Pass inspection by a department inspector [MCA 37-18-603(7), ARM 24.225.920(2)(a)]
- 3. List of all veterinarians and certified euthanasia technicians employed by the applicant [ARM 24.225.920(2)(c)]
- 4. Designate the certified euthanasia technician responsible for all aspects of euthanasia [ARM 24.225.920(2)(d)]

The following documents and additional forms are required <u>in addition</u> to the basic application. Some documents may be submitted directly by the applicant as part of the application. Others, such as transcripts, may need to be sent to the board directly from the source.

☐ Signed <u>Certified Euthanasia Agency Power of Attorney for DEA Order</u> form		
☐ Copy of completed DEA Form 224 application for registration (visit https://www.deadiversion.usdoj.gov/ for	•	
more information on the form and DEA requirements). Once the DEA has issued a number, the applicant		
must submit the DEA number to department staff.		
☐ If you answered yes to discipline questions, include a detailed explanation on the event(s) and		
documentation from the source (licensing board, federal agencies/programs, or civil/criminal court		
proceedings such as initiating/charging documents, final disposition/judgement documents, etc.).
