- 3) Submit a check or money order for \$457.00 made payable to the Board of Veterinary Medicine. Do not send cash. Canadian and foreign residents pay in U.S. funds only. The \$457.00 fee includes \$257.00 for the renewal and \$200.00 for the required annual inspection.
- 4) Renewals with a U.S. Postal Service postmark after May 30 will be assessed a penalty fee by state law of \$257.00, increasing the total amount due to \$714.00. NO EXCEPTIONS! That fee included \$514.00 for the renewal and late fee and \$200 for the inspection.
- 5) Sign the renewal application. Incomplete or unsigned renewal applications will not be processed and will be returned.
- 6) Return the following to the board office, postmarked by May 30: (1) the renewal application and fee; (2) verification of current DEA registration; and (3) a list of all currently employed certified euthanasia technicians (CET) and veterinarians with day, month, and year that each individual began employment and indication of which CET is responsible for all aspects of euthanasia at the agency.
